

Conditions of Participation and Data Privacy:

This promotion is in no way sponsored, endorsed or administered by, or associated with, Instagram. Receiver of the participant's data is not Instagram but FIDLOCK GmbH (District Court Hannover, HRB 204281), Kirchhorster Straße 39, 30659 Hannover, Germany, hereafter called "organizer". Participants cannot assert claims against Instagram that arise in connection with the participation in the promotion.

The participation is subject to the following conditions, which you expressly agree with participation:

1. Participation

The promotion begins on September 3rd, 2021 and ends on September 10th, 2021 at 23:59:59 (MEZ).

The participation is free of charge. Eligible for participation is everyone over the age of 18 with residence in Europe and a valid and public Instagram account. Employees of FIDLOCK GmbH and their relatives are excluded from participation. To participate, the post published by the organiser (FIDLOCK GmbH, @fidlockbike) on Instagram dated 03.09.2021 must be liked. In addition, the participant must tag at least one other person or more and follow @fidlockbike on Instagram.

By participating, the participant confirms their consent to the conditions of participation and their age of majority. To participate, it is necessary that all information provided to the organizer about the participant's identity is true. The organizer is not obligated to verify its accuracy or to make any relevant inquiries.

The participant undertakes not to post any illegal content.

2. Draw

Amongst the eligible participants that like the post by @fidlockbike, tag other people and follow @fidlockbike on Instagram, the lot decides, ensuring randomness, within one calendar week of the end of the participation phase. 3. Prize

Per round, every winner gets one TWIST bottle 800 + bike base sets, which will be send to them in the first week of october. Shipping is exclusively within Europe.
